

## Maintenance, Cleaning, and Removal

The cleaner must be wet, non-abrasive, without solvents, and have a pH value between 6 and 8 (neither strongly acidic nor strongly alkaline). 3M recommends using a steamer for removal. The correct angle of removal is 30 to 60 degrees from the surface of the paint.
